Additional Information

After the July 13, 2025, postal rate change, the next change is expected to be in January 2026. Rate changes are expected to occur twice a year.

County Actions

Per CIT 0181-21, the postage account should initially be funded with an estimated three months of postage and be replenished monthly with no less than the actual postage used in the prior month. The amount of postage used, and the remaining balance are available to each county's designated contact via the Central Print Portal. A Central Print Customer Liaison is also available to assist with information on the current postage balance and replenishment needs.
