1 OVERVIEW

PAR_ACT (variable #40 - Participated in First Activity) in Cal-OAR 19B identifies individuals who did or did not participate (with actual, verified attendance hours) in their first WTW or FS plan activity in the measurement month. PAR_ACT is the numerator of the first activity attendance rate.

Update CalOAR logic for PAR_ACT (Variable #40 - Participated in First Activity) - condition 1b.

1.1 Current Design

Existing CalOAR logic for PAR_ACT (Variable #40 - Participated in First Activity) follows the below criteria:

Note: Dependent on population of SCH_PACT (Variable #39 - Scheduled to Participate in First Activity)

- 1. SCH_PACT (Variable #39 Scheduled to Participate in First Activity) = 02 and Activity meets one of the following status conditions, then PAR_ACT (Variable #40 Participated in First Activity) = 02, otherwise 01:
 - a. Status = 'Active' and Status Reason = 'Attending'
- b. Status = 'Closed' and Status Reason = 'Interrupted', 'Off Aid After Start Date', 'Transferred to Another Activity', 'Unsatisfactory Performance'*, 'Drop out'**, 'Moved'**, 'Non-Compliance'**, 'Exempt'**, 'Good Cause'**, 'Assigned to Different Provider'** AND the activity has the previous activity Status = 'Active' and Status Reason = 'Attending' at any point in time in the measurement period.
- c. Status = 'Completed' and Status Reason = 'Completed Satisfactory', 'Employed' 2. Individual has a WTW/REP program in the measurement month

Note: (*) indicates Type is available in C-IV system only. (**) indicates Type is available in Los Angeles system only.

Note: Since all counties are now under one system, the status reasons for status 'Closed' will apply to all counties ('Unsatisfactory Performance' removed).

Response Options:

- 01 -Does not meet all criteria
- 02 Meets all criteria
- 99 Individual does not have a WTW/REP program in the measurement month

2.1.2 Description of Change

Update CalOAR PAR_ACT (Variable #40 - Participated in First Activity)
condition 1b to remove the checking for 'at any point in time in the
measurement period'.

Example 1:

Assume SCH_PACT (Variable #39 - Scheduled to Participate in First Activity) returns 02 for report month of September 2024. Say the activity has the following statuses:

- 'Active Attending' with a begin date of 9/1/2024 and an end date of 9/15/2024
- 'Closed Interrupted' with a begin date of 9/16/2024

For the September 2024 report, $PAR_ACT = 02$.

Example 2:

Assume SCH_PACT (Variable #39 - Scheduled to Participate in First Activity) returns 02 for report month of September 2024. Say the activity has the following statuses:

- 'Active Attending' with a begin date of 8/15/2024 and an end date of 8/31/2024
- 'Closed Interrupted' with a begin date of 9/1/2024

For the September 2024 report, PAR_ACT = 02.

2.1.1 Partner Integration Testing

After programming changes are made, CalSAWS will generate outbound Cal-OAR 19B test files for the report month of September 2024 which will be sent to CDSS. CDSS will review the files and send to a small cohort of counties to review and validate that the data is satisfactory.
