Description	<div><div>Purpose</div><div>The purpose of this CIT is to provide the details associated with the adjustment to the Counties' CalWORKs Administrative Advance for the SFY 2024-25 Third Quarter County Share of Costs for the CalSAWS system.</div><div>Background</div><div>CalSAWS member Counties are required to pay a County Share of Costs of the CalSAWS system. The County Share of Cost is calculated based on Persons Count. It was agreed that the method of payment would be in the form of an adjustment to each County's CalWORKs Administrative Advance. The Third Quarter of SFY 2024-25 will be applied to the July 2025 mid-month advance, reflecting each County's Share of Costs. The adjustment should be noted on each County's AA190.</div><div>Third Quarter Adjustments</div><div>The attached spreadsheet identifies the details associated with the adjustment for each County. For Maintenance of Effort (MOE) claiming purposes, the breakdown of each County's share for the CalFresh, Foster Care, and General Assistance programs has been included.</div></div>
