## **Meeting Notes: Region 1**

- 1. **FCED Update:** No update on the FCED as of today, training will be coming out soon next year, Go live in 2026. Preparation for the actual release. End of February through March.
- 2. **CNI Update**: SCR CA 282345 Rates will be updated 7/24/2025 and SCR CA 282348 Batch will run on 8/9/2025. A list will be provided to the counties.
  - a. NOA can be suppressed for the specific programs and counties have until 7/25/2025 to request the CNI NOA is held with a release date

#### 3. CER CA 284721: Add Page for Dependent Youth that Interfaces with MEDS:

Riverside County would like to add a new page for dependent youth (FC) that allows the interfacing with MEDS and automatically pull information from a Report for children enrolled in a Health Care Plan (IHEP) or other dependent youths are enrolled in. The report will have a summary and detail list by FC unit and/or county.

- a. Is this possible when the new MEDS system is implemented? The question will be asked if this could be transmitted into CalSAWS.
- b. If this information could be maintained in MEDS, users that have terminal operators can view information in MEDS.

This will be tabled when more information is provided by DHCS to CalSAWS.

#### 4. CER CA 292700 Add BRM envelopes to the KG2, AAP 3, and CSF 186 forms:

a. Kern County is requesting if the BRM envelopes be added to the programs in this CER. Tabled to next committee meeting.

#### 5. CER CA292701 FC 3 Enhancements: EW Signature and Expansion of Entry Fields:

a. Kern County wants to add the FC 3 form, have an electronic signature, and add more space on the form. Can we create an SCR? Votes submitted to vote and Region 1, 2, 3, 4, 5, 6 to create an SCR. SCR number CA-293080 was created for this effort.

#### 6. CER CA 287784 Create NSF Verification of Benefits form that includes FC, ARC, AAP and KG programs:

a. Workers are getting requesting for verifications of benefits and there is no form in CalSAWS specific to the foster care program. Regions agreed close this SCR and assign request to SCR CA-271427.

# 7. <u>CER CA 285209 Turn on AAP Discontinue NOA (NA 791) Reason-No Longer Legally/Financially Responsible</u>:

- a. Ventura would like the AAP NOA turned on when the AAP parent is no longer responsible legally and financially.
- b. There is an SCR that is updating this NOA with the correct language and the NOA is currently in production. This notice is turned off and not generating when terminating a case. SCR will be created for counties. SCR CA-293068 created for this effort.
