1 OVERVIEW

Based on ACL 12-25 a new Change Reason type will be added to allow the worker to utilize the Begin Date of the record as the Apply Date for program eligibility determination.

1.1 Current Design

Many data collection pages throughout CalSAWS include the Change Reason panel. When in Create or Edit mode, the Change Reason panel displays the New Change Reason drop-list and New Reported Date fields.

CalSAWS EDBC uses Change Reason logic to determine the benefit month for which data will be applied. The logic determines the apply date based on the Change Reason type, Report Date, and the Begin Date/End Date on the data collection page. In most instances, the Change Reason type is informational and does not affect the apply date. The exception is "State Hearing Decision" Change reason type which will immediately apply the new data to the program, regardless of positive or negative EDBC results.

1.2 Requests

Create a new Change Reason type that will immediately apply the new data to EDBC regardless of positive or negative impact benefits.

1.3 Overview of Recommendations

1. Create a new Change Reason of Apply Begin Date that will appear on all data collection pages where Change Reason fields are available.
2. Update EDBC logic to treat data with the Apply Begin Date Change Reason type as a Mandated type, similarly, to State Hearing Decision.

1.4 Assumptions

1. The EDBC Change Reason logic being updated by this SCR does not have an implementation date. Once this SCR is implemented, the modified EDBC logic will apply to any data old or new with the Apply Begin Date change reason.
2. This change will impact all programs which utilize Change Reason EDBC logic.
3. There is no impact to when and where the New Change Reason drop-list is displayed in the system.

4. The new Change Reason will display on the Change Reason List and Change Reason Detail pages.

2 RECOMMENDATIONS

Create a new option for the Change Reason drop-down list and update EDBC to consider the new reason as a mandated Change Reason type.

2. Update EDBC logic to take in the new Change Reason type (Apply Begin Date) and consider it as a Mandated type. The data should be applied in any month in which it exists based on the Begin Date of the data.
 - a. Update EDBC to set the Apply Date Reason to the Apply Begin Date value added in the previous section.

2.2.3 Example Scenarios

Example 1: For a CalWORKs/CalFresh combo case, add income for the current month (i.e. June 15th, 2025) for \$1000 with a Category of Earnings, Type of Salary, Wages, and a Frequency of Monthly. Run EDBC for the current month (i.e. June 2025) and future month (July 2025). The income should have an apply date of June 15th, 2025, and it should be applied for both the June and July benefit months.

Example 2: For a CalWORKs/CalFresh combo case, add income for the current month (i.e. June 15th, 2025) for \$1000 with a Category of Earnings, Type of Salary, Wages, and a Frequency of Monthly. Run EDBC for the future month (July 2025). The income should have an apply date of July 1st, 2025, and it should be applied for the July benefit month. Run EDBC for the June 2025 benefit month. The income should take effect, and the Apply Date of the Change Reason record should change and be June 15th, 2025.
