CA-250494 – Update CF MCE Journals and Trigger Conditions

1 OVERVIEW

This document outlines modifications and additions required to the CalFresh journal entries related to CE and MCE.

1.1 Current Design

The following journal entries are created based on various CalFresh budget determinations:

- 1. Journal Entry #1: Household is Modified Categorically Eligible**
 - a. Household's gross income did not exceed the limit for the TANF-funded service. PUB 275 was provided and the household was MCE conferred.
- 2. Journal Entry #2: Household failed the Gross Income Test.**
 - a. Household's gross income exceeded the limit for the TANF-funded service. Therefore, the household is no longer entitled to MCE, even though PUB 275 was provided to the household. The household's CalFresh benefits is terminated due to excess gross income limit."
- 3. Journal Entry #3: Household failed either the Net Income Test or the Property Test.**
 - a. Household's gross income exceeded the limit for the TANF-funded service. Therefore, the household is no longer entitled to MCE, even though PUB 275 was provided to the household. The household's CalFresh benefits is terminated due to excess net income/resource limit.
- 4. Journal Entry #4: Household is not Categorically Eligible.**
 - a. Since there is a sanctioned individual in the household, the CalFresh HH can not be conferred MCE.
- 5. Journal Entry #5: Household is Categorically Eligible and is not Modified Categorically Eligible.**
 - a. This Case is a CE Household and hence the CalFresh HH will be excluded from evaluating MCE.
- 6. Journal Entry #6: Not Eligible for Categorical Eligibility or Modified Categorical Eligibility Determination.**
 - a. CF Household was previously discontinued with reason Lottery or Gambling Winnings. Household is not eligible for CE or MCE determination.

These journal entries are dependent on the program remaining active or in pending status.

1.2 Requests

The request includes review of all CF MCE Journal Entry messages and conditions. This results in the modification of existing messages and the addition of new messages based on unique triggers. Additionally, allow for journal entries to generate when the

status is active, pending, discontinued, denied, or ineligible and based on case types. This is to resolve issues in the current design wherein if the program is discontinued, denied, or ineligible, then journal entries are not generated.

The requests are as follows:

1. Modify existing journal entry messages.

Journal Entry #:	Summary
1	Household is Modified Categorically Eligible
2	Household failed the Gross Income Test.
3	Household failed either the Net Income Test or the Property Test.
4	Household is not Categorically Eligible.
5	Household is Categorically Eligible and is not Modified Categorically Eligible.
6	Not Eligible for Categorical Eligibility or Modified Categorical Eligibility Determination

2. Add new journal entry messages.

Journal Entry #:	Summary
7	Household is not Categorical Eligibility or Modified Categorical Eligibility, and there is an IPV convicted person.
8	Household is not Categorical Eligibility or Modified Categorical Eligibility, and there is Fleeing Felon/Probation/Parole Violator person
9	Household is not eligible to Modified Categorical Eligibility due to zero benefit

3. The existing journal entries each have unique trigger conditions that are modified so that they may be generated when the program status is active, pending, discontinued, denied, or ineligible and based on case types.

1.3 Overview of Recommendations

The recommendations are divided into three groups:

1. Modify existing CE/MCE journal entry messages.
 - a. To modify existing journal entry messages, the following modifications are required:
 - i. Trigger Conditions
 - ii. Long Description
 - iii. Short Description
 - iv. Case Types
 - v. Journal Category
 - vi. Journal Type
 - vii. Long/Short Decode Name
 - viii. Code Number
 - b. NOTE: These changes are dependent on the request for each unique journal entry.
2. Add new CE/MCE journal entry messages.
 - a. To add new journal entry messages, the fields noted above are defined.
3. Modify the existing journal entry conditions to allow generation when the program is active, pending, discontinued, denied, or ineligible.
 - a. This is addressed individually for each journal entry in the Trigger Condition section above.

1.4 Assumptions

1. CalFresh functionality for households determined to be CE and MCE shall remain the same with the implementation of this SCR.

2 RECOMMENDATIONS

The following recommendation includes specifications for the modifications and additions to the CF CE and MCE Journal Entries.

1. Modify existing CE/MCE journal entry messages.

Journal Entry #1: Household is Modified Categorical Eligibility	
Trigger Condition	Generate when all the following are true: 1. The case type is Intake or Recertification. 2. The MCE Indicator is conferred meaning that the Modified Categorical Eligibility test result passes. <i>Note: The program status is active, pending, discontinued, denied, or ineligible.</i>
Long Description - Journal Entry Verbiage	The Household's gross income did not exceed the limit for the Temporary Assistance to Needy Families-funded service. PUB 275 was provided and the household was Modified Categorical Eligibility conferred.
Short Description	This Household is Modified Categorical Eligibility Conferred.
Case Types	Intake and Recertification Cases
Journal Category	Eligibility
Journal Entry #2: Household failed the Gross Income Test.	
Trigger Condition	Generate when all the following are true: 1. The case type is Intake, Ongoing, or Recertification. 2. The Gross Income test result fails. <i>Note: The program status is active, pending, discontinued, denied, or ineligible.</i>
Long Description - Journal Entry Verbiage	The Household's gross income exceeded the limit for the Temporary Assistance to Needy Families-funded service. Therefore, the household is not eligible to Modified Categorical Eligibility, even though PUB 275 was provided to the household. The Household is not eligible to CalFresh due to excess gross income limit.
Short Description	This Household failed the Gross Income Test.

Short Description	This Household failed either the Net Income Test or the Property Test.

Long Description - Journal Entry Verbiage	The CalFresh Household is not eligible to Categorical Eligibility or Modified Categorical Eligibility due to the Household containing an individual who has been convicted of an Intentional Program Violation.
Short Description	This Household is not Categorical Eligibility or Modified Categorical Eligibility, and there is an IPV convicted person.

Long Description - Journal Entry Verbiage	The Household's gross income exceeded the limit for the Temporary Assistance to Needy Families-funded service. The household's net income exceeds the maximum amount allowable for its household size and is entitled to a zero (0) benefit allotment. Therefore, the household is not entitled to Modified Categorical Eligibility, even though PUB 275 was provided to the household.
Short Description	This Household is not eligible to Modified Categorical Eligibility due to zero benefit.
Case Types	Intake, Ongoing, and Recertification Cases
Journal Category	Eligibility
Journal Type	MCE Determination
