Issue:

CalSAWS does not allow users to perform a Negative Action EDBC for CalFresh applicants under 22 years old living with parent(s).

Scenario: Adult child under the age of 22 years old submits a CalFresh application and parents have an active CalFresh case.

Per INC: 0153503, CalSAWS will only identify a case as separate CalFresh household if user answers Yes to the question “Customer (and Spouse) elects to request separate CalFresh household in the purchase and prepare record. This question only displays if user answers Yes to “Aged 60 or Older and will Request Separate CalFresh Household Due to a Disability.”

Proposed Recommendation:

Add a new negative action reason, “Not a Separate Household” to allow users to perform a negative action EDBC for CalFresh applicants under 22 years old living with parents.

Generate Client Correspondence with MPP 63-402.142

Verbiage: Separate household status shall not be granted to parents living with their natural, adoptive or step-children, or children living with their natural, adopted, or stepparents unless the child is 22 years of age or older and purchases and prepares meals for home consumption separately from his/her parents; or participating in the other parent’s CalFresh household.
