## Justification / Request Summary:

### Issue:

Current CalSAWS logic does not support sanctions being applied to Immediate Need the same way they do in CalWORKs.

This leads to potentially issuing incorrect Immediate Need/CalWORKs benefit amounts.

An override to EDBC is needed to correct the benefit amount.

Scenario: CalWORKs application dated 08/30/2024 for Parent and 1 child. Requesting IN. Parent is WTW sanctioned. Since sanction was not being applied to Immediate Need, CalSAWS wanted to issue incorrect benefit amount of \$59, instead of correct benefit amount of \$47

Per INC: 0154952 Resolution: "CalSAWS current logic is that the same sanctions from CalWORKs are not being pulled into the Immediate Need program. Parent may be sanctioned in CW, but still an active member in Immediate Need."

### Proposed Recommendation:

Update CalSAWS logic to include sanctions from CalWORKs to also be applied to Immediate Need.
