Justification / Request Summary:

Issue:

Currently in CalSAWS the Alien (A) Number is not a mandatory field and so users are not required to complete. This has caused issues with reports that need to be provided to the State and Feds regarding non-citizens and RCA cases. Staff are having to search for documents with the A Number information on it in Imaging or contact the customer to gather the information.

Proposed Recommendation:

Sacramento is requesting that the A Number field on the Citizenship Status Detail page be made a mandatory (*) field for users to complete. A “Not Applicable” checkbox can be added to the Citizenship Status Detail page when the customer doesn’t have an A # to provide, for example an Undocumented Citizenship Type.

Priority/Implementation Consideration(s):

High, without this data counties have to look for alternate methods to gather the data.
