Issue: Currently, when the self-employment income amount is equal to or less than the self-employment expenses. CalSAWS does not display the self-employment income/expenses in the CalFresh budget located in the CalFresh EDBC Summary Page

This is confusing to the user when reviewing the budget for accuracy.

Proposed Recommendation:

Enhance the EDBC Summary Detail page to display the self-employment income/expenses in the CalFresh budget, regardless of if the income is equal to/less than the expenses.”
