Justification / Request Summary:

Issue:

- 1) Eligibility to CFET requires eligibility to CF (ACL 22-99, page 8) Currently, the CFET program block can be manually opened/re-opened despite CF being inactive, the person not being aided in CF, or the person not being an active member of CFET - Job Retention Services.
- 2) Even though there is a batch to close CFET when CF closes (PB00M106) there is no automated action to set a task for review when this happens. CW/WTW have an automated action available to have WTW reviewed with CW closes.

Proposed Recommendation:

- 1) Create a Hard validation that when a user tries to enter a CFET "Enrolled" status for any activity other than "Job Retention Services" when the person is not an aided member of active CalFresh for the same month. The following message would display: "Unable to Save. [Individual Name] is not active in CF for this timeframe."
- 2) Add an automated action that counties can individually make active or inactive that would allow for a task to be generated when CF/CFET is discontinued in the PB00M106 batch to allow workers to review the action for either CF and/or CFET.
