 Approval of the updated Privacy and Security Agreement (PSA) between the California Department of Social Services (CDSS) and the California Statewide Automated Welfare System (CalSAWS).

Summary: The Consortium is seeking board approval of the updated Privacy and Security Agreement between CDSS and CalSAWS. The updated PSA replaces Privacy and Confidentiality citations with 45 CFR §205.50 et seq. and Welfare and Institutions Code section 10850 to focus on assistance programs administered by CDSS. Prior approved version cited similar sections focused on

Medical related programs administered under California Department of Health Services (CDHS). Similarly, the updated CDSS PSA removed language regarding "covered entity" under HIPPA. This updated version also applied minor format and cosmetic changes to the gareement.

c. Approval Deloitte Maintenance and Enhancement (M&E) Change Order 3, which includes two (2) premise items and three (3) County Purchases.

Summary: The Consortium is seeking Board approval of Change Order 3 that utilizes \$6,770,453 of the original \$60,842,031 change allocation for two (2) premise items: CalFresh Enhancement to Populate Income Page (\$419,690) and CalSAWS Interface (CARES) (\$6,350,763). Approval of this Change Order will leave \$51,993,748 for future Change.

This Change Order also utilizes \$370,108.89 of the original \$20,000,000 for County Purchases for three (3) County Purchases. Approval of this Change Order will leave a remaining balance of \$19,506,031 for future County Purchases. The County Purchase included in this Change Order is:
