# CA-270886 – Automate Reasonable Opportunity Period

## 1 OVERVIEW

Per ACWDL 25-13, if after the Reasonable Opportunity Period (ROP), verification of Satisfactory Immigration Status (SIS) cannot be obtained when it is required or if documentation establishing U.S. citizenship, U.S. National status or SIS is not provided, otherwise eligible individuals 19 years of age and older will be eligible for Restricted Scope benefits.

### 1.1 Current Design

The Reasonable Opportunity Period (ROP) field on the Citizenship page has no automated functionality meaning that workers must manually update the Citizenship Document to 'Undocumented' and set the ROP Expired field to 'Yes'.

With CA-277267 implemented in Release 24.11, a hierarchy is used to determine the Alien/Citizenship Indicator. When the Document is updated to 'Undocumented' in the Citizenship page, a MEDS EW12 transaction is automatically triggered and sends a value of "U" for the Citizen/Alien Indicator.

CalSAWS considers individuals that meet the following criteria as 'Undocumented':

1. The individual's Birth Country in Individual Demographics is not US or US Territory
2. There does not exist a Vital Statistics record for the individual with a verified US Citizen document
3. There does not exist a Citizenship Detail record for the individual or the Citizenship Detail record effective for the EDBC benefit month is for INS Document = 'Undocumented'

With CA-209076 implemented in Release 20.02,

1. eHIT was updated to send Admin-Verified 'No' for Refused records in a benefit month even if multiple other statuses exist in the same month.
2. The Citizenship Status Detail page was updated to hide Medi-Cal ROP section when 'Not Applicable' or 'Refused' is selected in the Verified drop down.
3. eHIT was updated to only send failed Admin-Verified when 'Pending' status is selected with Expired as 'Yes' in Medi-Cal ROP section or the Verified status is 'Refused'.

Currently, Medi-Cal EDBC rules grant Non-MAGI Restricted scope to individuals whose ROP has expired if the following is true:

1. Individual is aged 19 or older after 01/01/2026  
and,
2. Individual has one of the following on the Citizenship Status Detail Page
  - a. Verified = 'Refused'

- b. Verified = 'Pending' and ROP has Expired = 'Yes'

Currently, EDBC Sweeps check specific criteria based on the requirement to return only cases that will be processed (e.g. Person was returned in a DER as Discontinued). Cases that do not meet the set criteria are excluded from the run. Skips are registered in the Database and are Reported on. However, for Exclusions, there is no reporting or identification for the reason a case was not picked up and processed.

## 1.2 Requests

1. Individuals whose ROP has expired should automatically be updated to Restricted scope benefits.
2. Send a Notice of Action (NOA) when the ROP batch reduces the Medi-Cal from full to restricted scope.

## 1.3 Overview of Recommendations

1. Create a new batch to update the Document to 'Undocumented' on the Citizenship page when the ROP expires.
  - a. Update the field ROP Expired to 'Yes' automatically on the Citizenship page.
  - b. Create a new Batch Eligibility Sweep Code.
  - c. Update the Citizenship record for the individual whose Due Date for ROP has passed.
  - d. Send a new MAGI Request with Run Reason 'Continuing' for the come-up month.
  - e. Insert a trigger for Non-MAGI individuals for Batch EDBC.
2. Create a journal entry for cases where individuals ROP Expired field was updated to 'Yes'.
3. Create a new batch to run EDBC for the cases where a DER was received with the Batch Reason 'CT2813\_15.'
4. Create a new Batch Skip Reason.
5. Regression test MEDS EW12, EW20, and RC20 transactions.
6. Send a notice when the ROP batch reduces the Medi-Cal from full to restricted scope.

## 1.4 Assumptions

1. There is no change to the MEDS Citizen/Alien Indicator codes (DE 2009) logic. The logic is described in the design document for SCR CA-277267.
2. Individuals identified as Former Foster Youth (FFY) will remain in Full Scope Medi-Cal even if citizenship/satisfactory immigration status is not verified during the 90-day ROP. FFY individuals have Aid Code 4M.
3. Individuals identified as pregnant or within the 12-month post-partum period are not impacted if verification of Satisfactory Immigration Status (SIS) is not submitted prior to the ROP Due Date. These individuals have protection and are therefore eligible to Full Scope Medi-Cal.
4. An individual with an active Expansion Freeze (EF) Indicator for the EDBC Benefit month will be protected with Full Scope eligibility even when ROP is

expired and the 'Document' is updated to "Undocumented" on the Citizenship Detail Page with the implementation of this SCR or manually by a worker.

5. This SCR is only automating the expired ROP actions for individuals who are claiming SIS and are not born in the United States or one of its territories. If the individual is claiming they were born in the United States or one of its territories, they would not have a Citizenship record created, they would have a Vital Statistics record created. The Vital Statistics record does not have the Medi-Cal ROP fields that are present in the Citizenship Status Detail page. A separate SCR has been logged to automate the process for those with Vital Statistics records [CA-296181](#).

#### 2.3.1 Overview

---

Create a new batch job 'ROP Expiration Processing (CITZ, EDR, EDBC)', to update the ROP Expired indicator to 'Yes' and update the Citizenship record when the ROP Due Date has passed, send a new MAGI Request EDR to CalHEERS, and insert a trigger for Non-MAGI individuals for Batch EDBC.

#### 2.3.2 Description of Change

---

1. Create a new Batch EDR Run Reason (CT2813\_15) as follows:
  - a. Short Decode Name = ROP Expiration Processing (CITZ, EDR, EDBC)
  - b. Long Decode Name = ROP Expiration Processing (CITZ, EDR, EDBC)
  - c. Batch MAGI Sweep = PB00CH217
  - d. Batch EDBC Sweep = PB00E493
  - e. Reporting Indicator = Y
2. Create a new batch PB00CH217 'ROP Expiration Processing (CITZ, EDR, EDBC)' to perform the following actions (CT2813\_15):
  - a. Update the field ROP Expired to 'Yes' on the Citizenship page when the following is true:
    - i. The individual is an Active Member on the Medi-Cal program.
    - ii. The ROP Due Date is before the batch date.
    - iii. The field Expired is currently set to 'No' or <Blank>.
    - iv. The Citizenship record is high-dated.
  - b. Update the citizenship record for the individual whose 'Due Date' for ROP has passed.
    - i. Update the End Date of the high-dated Citizenship Record using the ROP Due Date as the new End Date.

- c. Create a new Citizenship record with the following information:
- i. New Change Reason = Participant Provided – Verbal
  - ii. New Reported Date = Batch Date
  - iii. Name = Name of identified individual
  - iv. Document = Undocumented
  - v. Country of Citizenship = Copy from prior Citizenship record
  - vi. Verified = Verified
  - vii. Sponsored? \* = Copy from prior Citizenship record
  - viii. Battered? \* = Copy from prior Citizenship record
  - ix. Is this an individual who worked 40 quarters or more, or the spouse, dependent child or unremarried surviving spouse of someone who worked 40 quarters or more? \* = Copy from prior Citizenship record
  - x. Is this individual a Hmong/Lao tribal member or the spouse, dependent child, or unremarried surviving spouse of a Hmong/Lao tribal member? \* = Copy from prior Citizenship record
  - xi. Is this individual presently on active duty in the US military or a honorably discharged veteran, or the spouse, dependent child, or unremarried surviving spouse of an active duty member or veteran? \* = Copy from prior Citizenship record
  - xii. Does this individual have, has applied for, or plans to apply for a T-Visa, U-Visa, or VAWA Petition? \* = Copy from prior Citizenship record
  - xiii. Begin Date = The Begin Date of the new record should be the day after the ROP Due Date

**Example:**

An individual has a ROP Due Date of 08/05/2026. The Batch is run on 08/17/2026. The existing Citizenship record is end dated as of 08/05/2026 and the new Citizenship record is created with a Begin Date of 08/06/2026 and is now the high-dated record.

**Note:** \* For the indicated fields, also include the associated 'Verified' field.

- d. Send a new MAGI Request for a Medi-Cal Program when all the following conditions are met:
- i. There is at least one individual whose Citizenship was updated and is an Active Member on MAGI.
  - ii. There is no EDR staged for the same Medi-Cal Program, Transaction Type Code, and Effective Date.
- Insert the following values:
- i. CalHEERS Transaction Type Code = 'Eligibility Determination Request' (CT297\_ED)
  - ii. Program ID = Program ID associated with the latest valid EDR or DER Transaction. If the latest valid EDR or DER is for a closed program, then use the Program ID associated to the latest Regular, Accepted and Saved EDBC for the active program with at least one Active MEM on a MAGI Aid Code.

Note: CA-273818, which will be implemented in Release 26.03, will introduce a new Batch MAGI Skip to skip a Medi-Cal program when the Primary Applicant on the active Medi-Cal program is not the same as the Primary Applicant associated to the Medi-Cal Program on the latest EDR or DER.

- iii. Effective Date = Come-up month
- iv. MAGI Run Reason = Continuing (CT395\_CO).
- v. Batch Indicator of 'Y'
- vi. Batch EDR Run Reasons = ROP Expiration Processing (CITZ, EDR, EDBC) (CT2813\_15)
- e. Create a new Batch Eligibility Sweep Code (CT942\_REX).
  - i. Short Decode Name: Batch EDBC ran for individuals with Expired ROP
  - ii. Long Decode Name: Batch EDBC ran for individuals with Expired ROP
- f. Stage the Medi-Cal Program for Batch EDBC processing with the values defined below based on the following criteria:
  - i. Check if the individual(s) processed on the case for ROP Expiration are all Active Members on Non-MAGI aid codes:
    - 1. If yes, stage the Medi-Cal Program for Batch EDBC processing with the values defined below.
      - a. Effective Date = Come-up month
      - b. Type Code = Batch Eligibility (CT626\_BE)
      - c. Sub Type Code = Batch EDBC ran for individuals with Expired ROP (CT942\_REX)
      - d. Created By = <Job's Staff ID>
      - e. Updated By = <Job's Staff ID>
      - f. Program ID = <Program ID associated with the Active Member on Non-MAGI>
      - g. Case ID = <Case ID associated to the Medi-Cal Program>
      - h. Run Type Code = Single Program (CT621\_SP)
    - 2. If no, do not stage Batch EDBC processing to allow the EDR to be processed by CalHEERS (Reference Section 2.4).
- g. Create a journal entry for cases where a new citizenship record was created for individual(s) with an expired Medi-Cal ROP.

    - i. is created by the <Job's Staff ID> for the ROP Expiration Processing (CITZ, EDR, EDBC) Batch Job,
    - ii. has a document type of 'Undocumented', and
    - iii. is created on the Batch Run Month.
  - c. For all Medi-Cal programs on the case of the DER, Run EDBC (post to SYS\_TRANSACT) where the impacted individuals are Active Members.

Insert the following values:

- i. Effective Date = Come-up month
- ii. Type Code = Batch Eligibility (CT626\_BE)
- iii. Sub Type Code = Batch EDBC ran for individuals with Expired ROP (CT942\_REX)
- iv. Created By = <Job's Staff ID>
- v. Updated By = <Job's Staff ID>
- vi. Program ID = <Program ID associated with the MAGI Determination>
- vii. Case ID = <Case ID associated to the Medi-Cal Program
- viii. Run Type Code = Single Program (CT621\_SP)

## **2.8.4 Form/NOA Generation Conditions**

### **1. Update Reason Fragment Generation Conditions**

Currently, the reason fragment **MC\_CH\_ALIEN\_STATUS\_VERIF\_FAIL\_M780\_NEW** (Fragment ID: 9531) is generated when there is a Medi-Cal scope change from Full Scope to Restricted Scope. Under this update, **MC\_CH\_ALIEN\_STATUS\_VERIF\_FAIL\_M780\_NEW** (Fragment ID: 9531) will stop generating when this SCR goes live and generates **MC\_CH\_ALIEN\_STATUS\_VERIF\_FAIL\_M159** (Fragment ID: 6573) when the following conditions are true:

- The program is Medi-Cal
- The Medi-Cal program is active
- The program person's scope has been changed from Non-MAGI Full scope to Non-MAGI Restricted scope.
- This notice will begin generating when the EDBC benefit begin date is on or after SCR go live date.

#### Suppression Logic

If MC\_CH\_EXPANSION\_FREEZE\_POSTPARTUM\_END\_M918 (Id: 11415), created in CA-295240 recommendation 2.7, generates the following will occur:

1. MC\_CH\_ALIEN\_STATUS\_VERIF\_FAIL\_M159 should not include the postpartum individual. Postpartum individuals will receive M918.
  - a. If the postpartum individual is the only member that is changing scope from Full to Restricted, M159 should be suppressed.
