These screens capture information about financial assets and accounts, property and vehicles.
Ishita	BenefitsCal Enhancements <ul style="list-style-type: none"> CSPM-80558: Account Creation OTP Improvements <ul style="list-style-type: none"> Release: 25.12.18 	<ul style="list-style-type: none"> Currently, within the Account Creation flow, an email address is required, and users have an option to add a phone number to their account. If they do, after verifying their email address with a one-time password, they have to enter a different one-time password sent to their phone number to complete the Account Creation Flow. This increases the possibility of users not successfully creating their account on BenefitsCal. On the first screen of the Account Creation flow, the optional field for mobile phone, and accompanying checkbox will be removed. Customers can add a phone number to their account after their first log-in. The field for County will also be removed since this information is no longer needed to determine whether the user can create an account. On the first screen of the Account Creation flow when a user enters an email address already in use, the page level error message is updated to suggest that the user log in if they already have an account, and to contact the county for help if needed. Password creation- special character field updated to remove parenthesis to avoid misleading customers that it is a usable special character. Language updated and simplified for customers adding their mobile phone number to their account. Customers have the option to modify their two-step verification preference during the same flow where they add their mobile phone number.

All references to CHDP removed.
