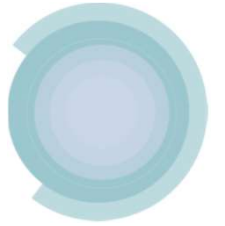

# Future SCR Scope



## CA-288712 - 25.09

Enhancements to Statewide Cash Aid Time Limits application

- **Review List**
  - Add Office/Unit information to search parameters and results
  - Add Search for Manual Clocks/Red Exclamation Mark records
  - Performance improvements to searches to handle outliers and give room for future enhancements with more complex searches
- **Adjust edit view fields to further differentiate from read view**
- **Add CalSAWS branding to SCATL**
- **Add button in CalSAWS Duplicate Person List page to copy CA TOA data to another CIN – security controlled**

## CA-289827 - 25.09

Modify Duplicate Time on Aid Review Page in SCATL

- Create new CalSAWS service to fetch EDBC and Issuance data
- Integrate new EDBC and Issuance services with Duplicate TOA Review page
- Integrate new EDBC and Issuance services with Program Detail page
- Add View Duplicate TOA right to allow for review of data without ability to merge
- Resolve logic related to merges of data when different counties own the conflicting record

## CA-291853 - TBD

Red exclamation mark cleanup

Apply SCR CA-283808 first - this updates the Aid code from Issuance for the converted records (red exclamation). This will not remove exclamation mark as the manual converted records will not be removed by this scr.

After the SCR applied:

1. Get records with red exclamation (converted records) and corresponding pgm participation with both pgm and aid code for the same eff date
2. Get the count of clocks both system and manual
3. Get these counts only for currently active cash aid pgm persons to review for patterns
4. Based on this review apply the data change
