## Description

### Purpose

The purpose of this CIT is to notify counties that the list for **CA-296567 Create a List of RCA/TCVAP Cases to Review for Potential Eligibility** has been posted to the CalSAWS Web Portal.

### Background

SCR **CA-289103 RCA, and TCVAP Cash Assistance time on aid updated to 4 months from 12 months** is scheduled for implementation in the 26.01 release. Until the system is updated with the new policy, workers will need to manually track Refugee Cash Assistance (RCA), and Trafficking and Crime Victim Assistance Program (TCVAP) cases that have an eligibility start date on or after 5/5/2025 and manually discontinue those cases at the end of four months of eligibility.

Individuals eligible to RCA and TCVAP Cash Assistance prior to 5/5/2025 will continue to be eligible for up to 12 months. Current CalSAWS batch processes will continue to discontinue this population at the end of the 12<sup>th</sup> month of eligibility.

A list of all **active** RCA/TCVAP cases with an eligibility period starting prior to May 5, 2025 will be provided at implementation of **CA-289103** to ensure this population retains 12 months of eligibility and the proper notice is issued.

**Additional Information**

An additional list is being provided to ensure the RCA/TCVAP population is reviewed for any potential benefit they may be entitled to. This list will include any denied or discontinued RCA/TCVAP cases within the last 12 months. The list will **exclude** the following:

- RCA cases that have a date of entry prior to 5/5/25 and have received 12 months of benefits.
- RCA cases that have a date of entry on or after 5/5/25 and have received 4 months of benefits.
- TCVAP cases that have an application date prior to 5/5/25 and have received 12 months of benefits.
- TCVAP cases that have an application date on or after 5/5/25 and have received 4 months of benefits.
