## Description

### Purpose

The purpose of this CIT is to notify counties that a list for **CA-297062 Modify MNB Batch query to exclude ICT data created by CalHEERs Webservice** has been posted to the CalCAWS Web Portal.

### Background

[ACL 25-59](#) added policy for eligible Elderly Simplified Application Project (ESAP) CalFresh households receiving less than \$60 monthly CalFresh allotment with an additional state-funded monthly MNB that is equal to the difference between their monthly CalFresh allotment and \$60 beginning January 1, 2026. SCR CA-292335 was released into production on 25.11 in CalSAWS. With the implementation of the MNB program, ICTs (Inter County Transfer) were not being discontinued if the CalFresh monthly allotment increased over the \$60 monthly allotment due to the CalHEERs Webservice interface causing the MNB benefits to continue being issued in the receiving county to ineligible CalFresh recipients.

### Additional Information


With the implementation of SCR CA-297062 scheduled for minor release 26.02.xx, the MNB Batch query will exclude the ICT data that is being created by the CalHEERS interface. A list of cases is being provided to the counties of the ICT cases that will need to be manually discontinued and send a discontinuance NOA CF 378B – Notice of Discontinuance for the CalFresh Minimum Nutrition Benefit Pilot Program.

Counties should review the list in Tab 1 of the spreadsheet and take action by manually:

1. discontinuing the CalFresh household for the MNB program through the Auxiliary Authorization Detail Page by updating the End Month for the auxiliary record.
2. generating the NOA CF378B – Notice of Discontinuance for the CalFresh Minimum Nutrition Benefit Pilot Program.
