# CA-294574 H.R.1 ACL 25-50 Changes to CalFresh Eligibility for Most Lawfully Present Non-Citizens

## 1 OVERVIEW

### 1.1 Current Design

1. CalFresh EDBC determines non-citizen eligibility to the program based on the document type and section codes combination eligibility stored in the code table. Once the individual is determined to have an eligible combination of 'Document Types' and 'Section Codes' (a.k.a. Citizenship Documents for the purpose of this document), EDBC will determine if the individual is eligible to receive federal funded CalFresh or state funded CFAP as follows:

Individuals are not subjected to the 5-year waiting period and become eligible to federal CalFresh if they qualify for any for the following exemption conditions:

- a. If the member is unconditionally CalFresh federally eligible based on their INS Citizenship Category. These qualified aliens are eligible to receive federal CalFresh indefinitely they are admitted or granted one of the following statuses. These are:
  1. Refugees
  2. Asylee
  3. LPR Asylee
  4. LPR Cuban Refugee
  5. LPR Indochinese Refugee
  6. LPR Amerasian
  7. LPR Refugee
  8. Deportation withheld
- b. If the members Entry date or INS Document Issue Date is at least 5 years prior to the begin date of the 'Benefit Month.' Exception: this does not apply for members on U-Visa document
- c. If the 'Member' is one of the following: These are:
  1. Born in the USA
  2. Has a citizenship type of 'Naturalized US Citizen'
  3. Has a citizenship type of 'US Born Abroad'
- d. Determine if the 'Member' is a 'Hmong' <sup>1</sup> or a 'Highland Lao Tribal Member' <sup>1</sup> as indicated by the INS document type and section code and is qualified because of Hmong information (Hmong indicator on Citizenship set to 'Yes')
- e. If the 'Member' is a 'Cross Border American Indian' <sup>1</sup> as indicated by the INS document type and section code
- f. Determine if the 'Member' is under 18 and the 'Benefit Month' is 10/1/2003 or later

- g. If the 'Member' is under 18 and the 'Member's' entry date or INS document issue date is before 8/22/1996
- h. If the 'Member' is 'Disabled' or 'Blind' or has 'Other FS Disability'
- i. If the person qualifies because of military information (Meets Veteran Status Active Duty indicator on Citizenship set to 'Yes' or person is a lawful permanent resident veteran as indicated by his document code and section code)
- j. Determine if the 'Member' is a 'Lawful Permanent Resident,' as indicated by his document code and section code, and qualifies for 40 quarters (40 qualifying work quarters indicator on Citizenship set to 'Yes').
- k. Individuals citizenship type of 'Parolee' with date of entry between 02/24/2022 and 09/30/2023 and has any of the following section codes:
  - a. UHP
  - b. U4U
  - c. 212(d)(5) or 8 U.S.C. § 1182(d)(5)
  - d. 212(d)(5)(A) OAR
  - e. 212(d)(5)(A) OAW
  - f. 212(d)(5)(A) DT
  - g. C11
- l. Individuals with the following section codes:
  - a. S18
  - b. SQ8

If the individual is not eligible for federal CalFresh based on the above conditions, then the household is eligible for CFAP.

- 2. Non Citizens with citizenship type 'Parolee' and with a parolee type 'Parolee-Less than 1 year' are not eligible for Federal CalFresh or CFAP.

## 1.2 Requests

- 1. Limit CalFresh eligibility to U.S. Citizens, Lawful Permanent Residents, Compacts of Free Association (COFA) migrants, Cuban and Haitian entrants under the Refugee Education Assistance Act of 1980.
- 2. Update INELIGIBLE ALIEN fail reason verbiage for CF 377.1A Denial and CF 377.1 Partial Approval.
- 3. Add INELIGIBLE ALIEN NOA fragment for CF 377.4 SAR CalFresh Discontinuance.

## 1.3 Overview of Recommendations

- 1. Update CalFresh and CFAP eligibility determination for non-citizens based on HR1 policy
- 2. Update INELIGIBLE ALIEN fail reason verbiage for CF 377.1A Denial and CF 377.1 Partial Approval.
- 3. Add INELIGIBLE ALIEN NOA fragment for CF 377.4 SAR CalFresh Change and Discontinuance.

## 1.4 Assumptions

1. Citizenship detail page shall remain unchanged with the implementation on this SCR.
2. Per current functionality, for CalFresh program, Ineligible non-citizens are not closed from the program, the applicant is set to 'FRE' with a role reason of 'Ineligible Non-Citizen'. This functionality shall remain unchanged with this SCR.
3. No impacts to TCF/SNB/TNB program.
4. Current functionality to determine each of the non-citizen federal eligibility requirements mentioned in the current design shall remain unchanged unless specifically mentioned in the requirements of this SCR below.

### 2.2 Update CalFresh Non-Citizen Eligibility Determination

#### 2.2.1 Overview

When running CalFresh EDBC, non-citizen eligibility is determined based on the citizenship documents for the individual. Eligible citizenship documents will be accessed for CalFresh (Federal benefits) or CFAP (State benefits) eligibility. Update eligible citizenship documents for CalFresh based on HR1 policy effective 4/1/2026. For all eligible citizenship documents, update EDBC logic for eligible individuals to determine Federal CalFresh or CFAP funding based on the HR1 policy changes.

Update non-citizen eligibility determination to be at intake and recertification only. If the individual is determined to be eligible during intake and RE, the individuals shall remain eligible for the entire certification period regardless of the

changes to the citizenship documents mid-period. If the individual is determined to be not eligible for benefits due to citizenship document (FRE, Ineligible Non-citizen) during Intake and RE, running EDBC for any month during the certification period shall evaluate non-citizen eligibility to the program for the benefit month based on mid-period changes.

### 2.2.2 Description of Changes

1. Update code detail table to reflect the document type and section codes eligible for CalFresh and CFAP program. The treatment of each combination of document type and section code (Citizenship document) is outlined in 'CA-294574 CalFreshNonCitizenEligibilityUpdates\_Fed\_CFAP' excel document referred in the supporting document section 3.1 of this document and attached in JIRA. Eligibility to CalFresh or CFAP shall be accessed for citizenship documents marked as eligible in the code detail table.
  - a. Update the CalFresh classification column with the updates to citizenship documents mentioned in the 'Federal CalFresh Eligibility' page in the excel document.
    - i. Existing records for the impacted citizenship documents shall be end dated to 3/31/2026.
    - ii. New record beginning 4/1/2026 to high date shall be added with the updated CalFresh eligibility. All other reference columns shall remain the same.
  - b. Add new 'CFAP Classification' reference column to capture the citizenship document that are eligible for CFAP determination.
  - c. Update the new CFAP classification column with the CFAP eligibility as defined in 'CFAP Eligibility' page of the excel document.
2. Update EDBC logic to effective date the updates to determine Federal CalFresh or CFAP eligibility changes outlined in this recommendation 2.2 and shall be referenced as '**HR1 Policy Effective Date**' as follows:
  - a. The changes described below will be effective for new applications with an application date 04/01/2026 and after. Or
  - b. The changes described below will be effective for ongoing applications and new applications with source 'ICT' at recertification with an RE due date 04/2026 or after.

CalFresh EDBC shall use the current functionality outline in section 1.1 for benefit months where the CalFresh application **does not** qualify for the above criteria.

3. Update EDBC logic to determine federal CalFresh or CFAP eligibility for the following 'Parolee' citizenship types with the following section codes regardless of the parolee types effective '**HR1 Policy Effective Date**':
  - a. M93
  - b. PH6
  - c. U4U
  - d. UHP

Note: current functionality to determine federal eligibility for section codes 'U4U' and 'UHP' with date of entry between 02/24/2022 and 09/30/2023 shall remain unchanged.

#### 4. Update federal eligibility determination:

For all citizenship documents marked eligible in the CalFresh classification column of the code detail table mentioned above, EDBC logic shall determine if the individual can qualify for federal benefits without the 5-year waiting period if they are eligible for any of the exceptions mentioned in the current design section (Section 1.1).

Update the exceptions that qualify the individual for federal benefits effective '**HR1 Policy Effective Date**' as follows:

- a. Update CF EDBC rules for eligible citizenship documents to not provide federal claiming for the following citizenship types:
  - i. Refugee
  - ii. Asylee
  - iii. Deportation withheld
- b. Update EDBC logic to identify latest citizenship document available prior to the current citizenship documents valid for the benefit month. If the prior citizenship document is eligible to the program, determine federal funding if the individual's prior citizenship document is one of the following citizenship types:
  - i. Refugees
  - ii. Asylee
  - iii. LPR Asylee
  - iv. LPR Cuban Refugee
  - v. LPR Indochinese Refugee
  - vi. LPR Amerasian
  - vii. LPR Refugee
  - viii. Deportation withheld

Note: Qualifiable exceptions for federal eligibility not mentioned above shall remain unchanged and determine the individual eligible to qualify for federal benefits.

#### 5. **Update CFAP eligibility determination**

For all citizenship documents marked eligible in the CFAP classification column of the code detail table mentioned above, update EDBC logic to determine if the individual can qualify for CFAP benefits effective '**HR1 Policy Effective Date**' as follows:

- a. The individual **does not** meet any of the exceptions outlined above and the exceptions outline in the current design section that remain unchanged that can qualify the individual for federal benefits.
6. Update non-citizen eligibility determination to be at Intake and recertification only.

This update to EDBC logic shall not be limited to an effective date and shall be applicable to any benefit month the EDBC is processed upon implementation of this SCR:

- a. Update EDBC logic to determine non-citizen eligibility to CalFresh or CFAP based on the individual's citizenship documents applicable for the benefit month when any of the following conditions are met:
  - i. EDBC benefit month is the same month as the person application aid begin date (BDA) and source of the application is **not** 'ICT'

**Commented [SM1]:** Not limiting to applications going from pending to active to allow corrections



- ii. EDBC is run with any of the following run reasons:
    - 1. RE
    - 2. Elect Regular
    - 3. Elect Regular/RE
  - iii. Individual currently 'Active' with 'FRE/UP' role for the benefit month.
  - iv. Individual is active 'MEM' and the latest non-citizen determination at Intake or RE was overridden by the worker.
  - b. Update EDBC logic for individuals to continue the non-citizen eligibility and funding source as previously established when running EDBC for any of the following ongoing benefit months:
    - i. EDBC benefit month is not the same month as the person application aid begin date (BDA) unless source of the application is 'ICT'
    - ii. EDBC is **not** run for any of the following run reasons:
      - 1. RE
      - 2. Elect Regular
      - 3. Elect Regular/RE
    - iii. Individual currently 'Active' with 'MEM' for the benefit month.
- Note: ICT cases shall be treated as ongoing as an ongoing CalFresh application when determining non-citizen eligibility for the intake month in the receiving county.

### 2.2.3 Example Scenarios

Disclaimer: The below scenarios **are not** requirements. They are meant to help guide understanding and testing and may mention items that are not being changed by the specific language in the requirements.

#### Ongoing Case Scenario:

1. CF HH of 1, PN01. PN01 is a non-citizen with the following citizenship document:
  - Document Type: I-94
  - Section Code: 208
  - Citizenship Type: Asylee
 PN01 applied for CalFresh benefits with a BDA of 01/01/2023. Running EDBC for 01/2023, HH was eligible for CalFresh and was determined federal funding. HH is currently active for 04/2026 benefit month with a certification period from 01/2026 – 12/2026

#### Example1:

Running EDBC for 04/2026, the HH shall continue to be eligible for federal CalFresh benefits until recertification. Running EDBC for 01/2027 to establish a new RE, the HH shall be reevaluated and with no changes to citizenship documents the individual shall not be eligible for benefits.

#### Example2:

On 4/20/2026 an ICT was initiated for the case. Case was transferred from CountyA to CountyB effective 05/2026 benefit month. Running EDBC for 05/2026 in CountyB, the HH shall continue to be eligible for federal benefits until recertification on 01/2027.

Example3:

PN01 has a change in citizenship documents effective 10/01/2026:

- o Document Type: I-151, I-551, Passport or I-94 Annotated with I-551 & Section Code
- o Section Code: TW2
- o Citizenship Type: Lawful Permanent Resident

Running EDBC for 10/1/2026 EDBC shall continue evaluate PN01 to be eligible to CalFresh Federal benefits since PN01 was evaluated to be eligible for federal CalFresh at intake 01/2026. Running EDBC for 01/2027 with run reason 'RE' shall evaluate the individual eligible for CalFresh and qualify for federal benefits since the prior citizenship documents qualify for federal without any waiting period (previous citizenship type: Asylee)

Intake Case Scenario:

1. CF HH of 1, PN01. PN01 applied for CalFresh Benefits on 4/20/2026 with a BDA of 05/01/2026. PN01 is a non-citizen with the following citizenship documents:
  - Document Type: **I-151, I-551, Passport or I-94 Annotated with I-551 & Section Code**
  - Section Code: **TW2**
  - Citizenship Type: Lawful Permanent Resident
  - Date of entry: 08/01/2021

Example1:

Running EDBC for 05/2026 benefit month, PN01 meeting all other eligibility conditions for CalFresh shall be determined eligible to CFAP benefits with a 12-month certification period.

Example2:

For 09/2026 benefit month. With no changes to the case, PN01 meets the 5-year waiting period requirement to qualify for federal benefits. Running EDBC for 09/2026, PN01 shall continue to be eligible for CFAP benefits until recertification.

Example3:

Running EDBC for 05/2027 with run reason 'RE' and no other changes to the case, PN01 shall be determined to be eligible for federal CalFresh benefits.

2. CF HH of 2, PN01 and PN02. PN01 is a US citizen and PN02 is 16 years of age and is a non-citizen with the following citizenship documents:
  - Document Type: **I-797**
  - Section Code: **U-3**
  - Citizenship Type: Other Non-CitizenCF HH applied for CalFresh Benefits on 4/20/2026 with a BDA of 05/01/2026.

Example1:

Running EDBC for 05/2026 benefit month, PN01 meeting all other eligibility conditions for CalFresh shall be determined Eligible to Federal benefits. PN02 shall be determined 'FRE' with role reason 'Ineligible Non-Citizen' since the citizenship document is not eligible for federal benefits under HR1 and 'Under 18 years' is a federal qualifiable exception without the 5-year waiting period, PN02 is not eligible for CFAP.

Example2: PN02 turns 18 for 08/2027 benefit month. Running EDBC for 08/2027 with no other changes to CalFresh eligibility, PN02 shall be eligible for CFAP benefits.
