Current Design: When a document is linked to a new case in BenefitsCal, the document is sent back through the entire workflow, including OCR, again.
Request: Sending these documents through OCR again is unnecessary step since the documents have already gone through OCR once, and do not need to be classified again. Sending those documents to OCR a second time takes up system resources that are already heavily impacted.
Update the routing so that documents with "Portal" in the capture information and an existing batch number in the OCR Batch field are routed to Task Generation instead of OCR. This will lessen the impact to OCR and free up those resources for other documents.
Recommendation: Add a routing rule to Pre-OCR to check for Capture Information = "Portal" and OCR Batch is not equal to NULL. If true, send to the Task Generation queue.
