The workbook does include estimates for county-specific items for prior CalWIN counties which include: county support staff personnel, county-provided hardware maintenance, county-provided software maintenance, and local area network.

The costs included in the workbook are estimates and subject to change based on actual costs as paid each month, subsequent allocation adjustments, and updates to the CalSAWS Operational Advance Planning Document Update (OAPDU) and the Advance Planning Document Updates (APDUs) for the premise projects listed above.

The costs reflected on the summary tabs of the workbook account for the quarterly invoice/claim process and the individual county shares are based on the applicable SFY Persons Count.
