Description	<p>Purpose</p> <p>The purpose of this CIT is to provide the counties with the second in a series of bulletins specific to the CalSAWS Workload Management effort, called the “Workload Management Bulletin.” The Workload Management Bulletin is designed to communicate upcoming system changes and keep counties informed of activities as they pertain to Workload Management enhancements.</p> <p>Background</p> <p>As part of the Organizational Change Management (OCM) efforts supporting Workload Management and SCR CA-293073 Phase 1, scheduled for production in May 2026, monthly bulletins are being provided to counties to support awareness and readiness.</p> <p>This effort builds on foundational work completed by the 2024 Workload Management Workgroup, SCR CA-274189. In 2025, a new workgroup was assembled with representatives from all six regions to review the requirements approved by the 2024 Workload Management Workgroup and to ensure the system design aligned with the</p>
