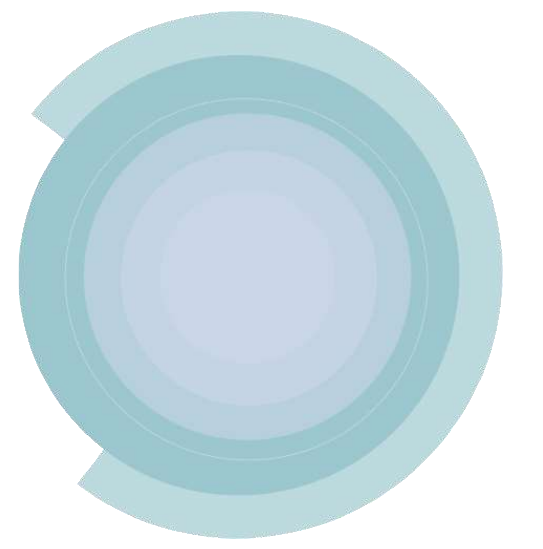

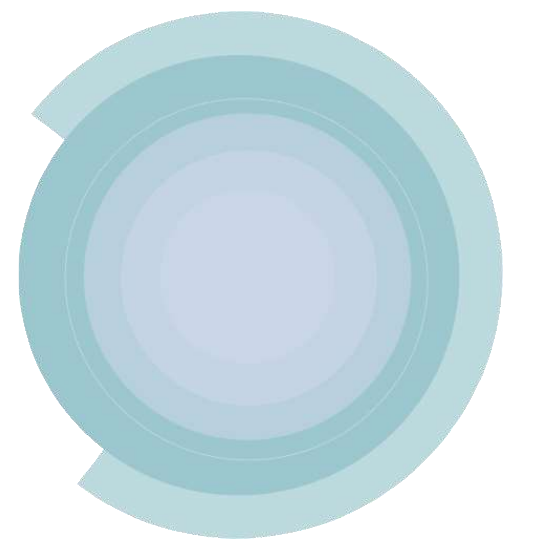

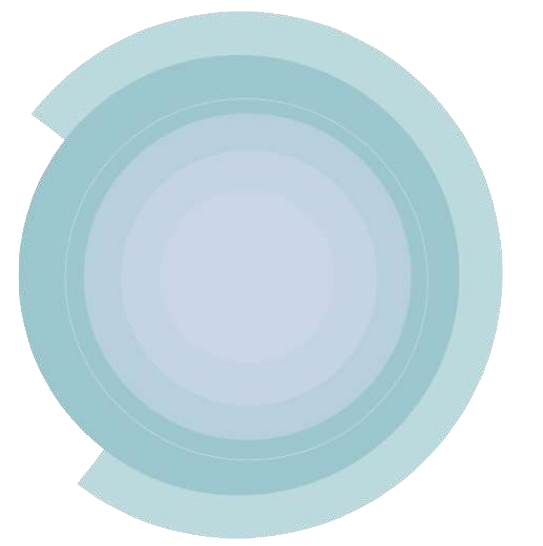

# Medi-Cal HR-1 Policy Roadmap\*



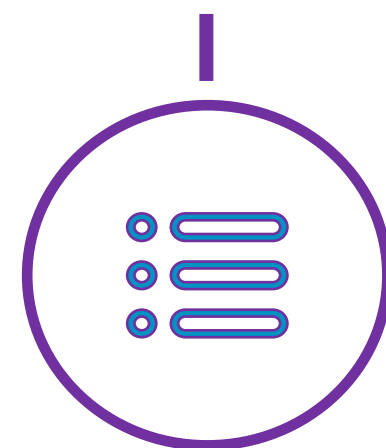
