

**AMENDMENT #2 TO LEGAL SERVICES AGREEMENT  
BETWEEN  
CALSAWS CONSORTIUM  
AND  
KRONICK, MOSKOVITZ, TIEDEMANN & GIRARD**

This Amendment #2 ("Amendment") to the Legal Services Agreement ("Agreement") is entered into by the CalSAWS Consortium ("Consortium") and Kronick, Moskovitz, Tiedemann & Girard ("Kronick") (collectively, "Parties") as of May 15, 2026 ("Effective Date").

WHEREAS, in or about August 2018, the Consortium and Kronick entered into the Agreement whereby Kronick agreed to provide both general and special counsel legal services to the Consortium; and

WHEREAS, the initial base term of the Agreement was for a period of five(5) years with three (3) one-year options to be exercised by the Consortium at its discretion; and

WHEREAS, on or about April 1, 2024, the Parties entered into Amendment #1 to the Agreement whereby the Consortium exercised its three (3) one-year options thereby extending the Agreement to August 2026 and provided to Kronick a rate increase for legal services provided pursuant to the Agreement; and

WHEREAS, the Parties now desire to extend the Agreement further subject to the terms and conditions as set forth in this Amendment.

NOW, THEREFORE, the Parties agree as follows:

**1. Extended Term of Agreement.** The term of the Agreement will be extended for a two-year period beginning on August 24, 2026 and running to August 23, 2028.

**2. Rates For Legal Services During Extended Term.** Kronick agrees that during the two-year period described in Section 1, it will not raise the hourly rates charges the Consortium for legal services. The rates Kronick will charge Consortium for legal services during the extended term are as follows:

Shareholder/Of Counsel (David Tyra only)	\$390
Of Counsel (other than David Tyra)	\$355
Senior Counsel	\$355
Associate Counsel	\$340
Paralegal	\$200
Law Clerk	\$200
Document Clerk	\$175

**3. Additional Option Years.** Following the expiration of the Extended Term described in Section 1 above, the Parties agree to four (4) one-year optional extensions of the Agreement, which such options may be exercised at the sole discretion of the Consortium. In the event the Consortium exercises all four (4) option years, the Legal Services Agreement between the parties would expire on August 23, 2032.

**4. Rates For Legal Services During Option Years.** In the event the Consortium exercises its options to extend the Agreement as described in Section 3 above, the rates charged by Kronick for legal services in those optional years will be as follows:

Option Year 1: A seven point five percent (7.5%) increase of the rates charged during the Extended Term at all levels of Legal Services Professionals listed in Section 2.

Option Year 2: A five percent (5%) increase over the rates charged in Option Year 1 at all levels of Legal Services Professionals listed in Section 2.

Option Year 3: A three point five percent (3.5%) increase over the rates charged in Option Year 2 at all levels of Legal Services Professionals listed in Section 2.

Option Year 4: A three percent (3%) increase over the rates charged in Option Year 3 at all levels of Legal Services Professionals listed in Section 2.

**5. Remaining Terms Of The Agreement.** Except as amended herein, all other terms of the Agreement between the Parties will remain in full force and effect during both the Extended Term as well as all Optional Years.
