Description	<p><b>Purpose</b> The attached communication will explain the changes to Retroactive Medi-Cal benefits that will be effective on January 1, 2027 as part of H.R. 1, and included in the CalSAWS 26.06 release on June 15, 2026.</p> <p><b>Background</b> In release 26.06 CalSAWS will implement new logic in preparation for changes to Retroactive benefits for Medi-Cal that will go into effect for H.R. 1 on January 1, 2027.
