Description

Purpose

The purpose of this CIT is to provide Counties with one-pagers detailing the Medi-Cal policy-related System changes included in the CalSAWS 26.09 release.

Background

With release 26.09, CalSAWS will include three System Change Requests (SCRs) which implement new logic in preparation for changes to Medi-Cal policy.

CA-292582 and CA-292586 implement H.R. 1-related System changes. CA-294491 is included due to its overlap with H.R. 1-related changes, though it is related to the California State Budget rather than an H.R. 1 provision.

The attached one-pagers detail what changes County Eligibility Workers (CEWs) can expect to see in CalSAWS once the policy changes go into effect in January 2027.
